There is no cost for the call, to use the service or to speak with a Disaster Case Manager.

Regardless of the amount of funds or assistance you may have already received from your insurance policy or local, state and federal programs, a Disaster Case Manager is available to speak with you.

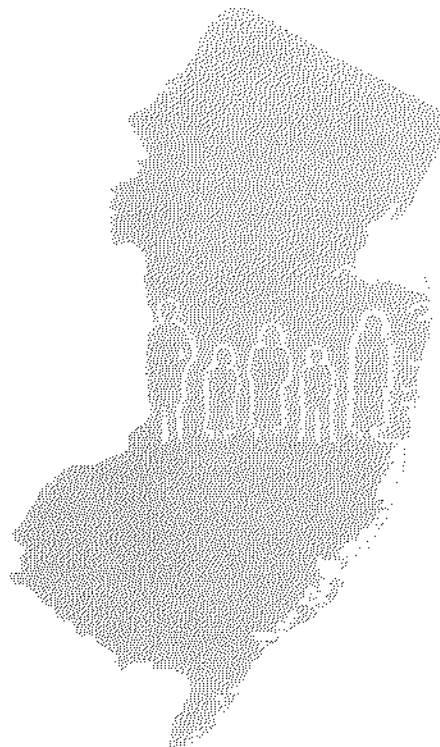

SBA offers federal disaster loans to Homeowners, Renters & Businesses for disaster-related losses!

- Up to **\$200,000** for Real Property (Homeowners)
- Up to **\$40,000** for Personal Property (Homeowners & Renters)
- Up to **\$2 Million** for physical property damage (Businesses of any size)
- Up to **\$2 Million** for working capital (Small Businesses & Non-profits)

Interest rates as low as:

- **1.688%** for Homeowners and Renters
- **3%** for Private Non-profit organizations
- **4%** for Businesses

Terms of up to **30 years** to repay the loan

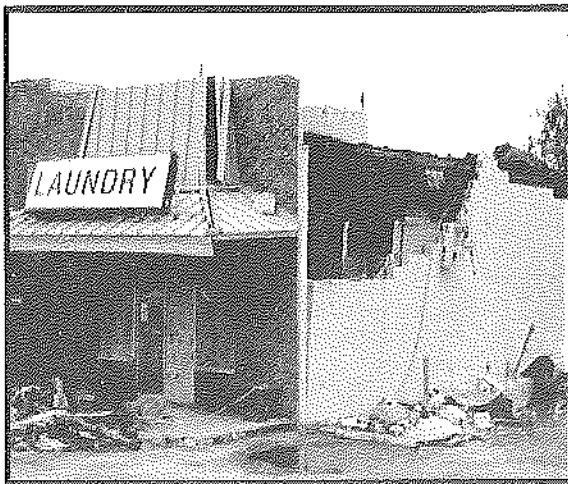

- Real Estate, Machinery & Equipment, Inventory, Other Business Assets

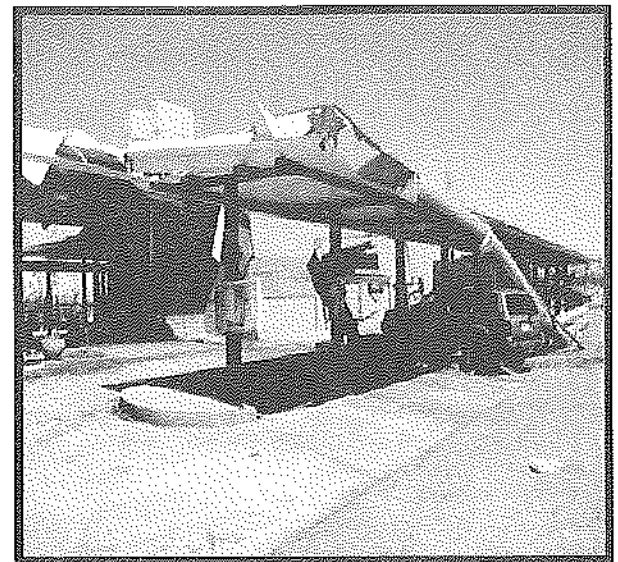
**Small Businesses & most private Non-Profits

- Up to **\$2 million** for Economic Injury to meet working capital needs
- No physical damages necessary to qualify

Interest Rates are as low as:

- 3%** for Non-Profit Organizations
- 4%** for businesses of any size
